Ya Nangoloh sues SWAPO

Cites Namibia Today as first defendant

"You (Ya nangoloh) started this fight. Have the courage to see it through. We at Namibia Today

have vowed to quash your anti-Nujoma antics. You, (Ya Nangoloh) by design, have thrust that responsibility on our shoulders. We will fight you. If you want this fight to the end, we will give it to you.

"For the sake of democracy, peace and stability in Namibia, we will expose and shred your lies. And name and shame those who are urging you on. Ya Nangoloh is a pathological liar and has come out as such so brilliantly during his Tuesday's (last year) press conference."

Ya Nangoloh said in his summons that he had been "humiliated and degraded" by such publication and had "suffered damages in the amount of N\$250 000."

Namibia Today called Ya Nangoloh a pathological liar last year, following his claims that Founding President Sam Nujoma and National Assembly Speaker, Dr Theo-Ben Gurirab, were "agents" of the Central Intelligence
