AGRICULTURAL BANK OF NAMIBIA

Egyptian FM affirms his country's support for security, stability in Sudan

KHARTOUM, — Egyptian Foreign Minister Ahmed Aboul Gheit on Thursday reiterated here his country's full support of Sudan's security and stability, and keenness to help it overcome difficulties facing implementation of the comprehensive Peace Agreement (CPA) and conduction of south Sudan referendum."Egypt is keen on security and stability in Sudan particularly when we are approaching a sensitive phase in the history of the relation between north and south Sudan," Aboul Gheit told reporters in Khartoum.

Egyptian Foreign Minister Ahmed Aboul Gheit and Chief of Intelligence Service Omar Suleiman on Thursday held separate talks in Khartoum with Sudanese President Omar al-Bashir and his Vice President Ali Osman Mohamed Taha.

The Egyptian foreign minister delivered a message from Egyptian President Hosni

Mubarak, noting that "the message included President Mubarak's desire to follow the situation in Sudan and the views of the Sudanese leadership towards the current issues."Sudanese Minister of Foreign Affairs Ali Ahmed Karti, for his part, told reporters that "we see Egypt's support for Sudan and the visit of this delegation indicates Egypt's great support for Sudan's current issues."

The Egyptian foreign minister arrived in Khartoum on Thursday in an official one-day visit to Sudan.

A referendum on self-determination for southern Sudan is expected to be held on Jan. 9, 2011 to decide whether the region should remain united with north Sudan or secede and establish an independent state. The referendum has been stipulated by the CPA, inked between north and south Sudan in 2005. (Xinhua)

Syrian president, South African deputy president discuss bilateral ties

DAMASCUS, — Syrian President Bashar al-Assad and visiting South African deputy President Kgalema Motlanthe discussed bilateral ties on Thursday, the Syrian official SANA news agency reported.

Kgalema stressed his country's desire to develop its relations with Syria due to Damascus' key role in the region.

Assad expressed Syria's great appreciation for South Africa's stances towards

Arab issues, particularly its support to restore the occupied Syrian Golan Heights and the Palestinian cause, the report said.

Syria and South Africa have been engaging in recent years to create proper atmosphere for boosting trade and investment between the two states.

Kgalema Motlanthe arrived in Damascus on Wednesday for a three-day visit to strengthen the bilateral relations. (Xinhua)
